

## 2016 Chalani Chilled Semen Breeding Contract – Chalani Sunstream

This Breeding Contract for the breeding season of September 2016 to December 2016, is made and entered into on (Date) .....

### 1. I require my mare to be bred by chilled semen.

The service fee of **\$900** and semen collection fee of **\$250** is to be paid in advance of any semen being shipped. Any costs associated with transportation or shipping of semen will be billed to the mare owner.

The Service fee is to be paid per nominated mare **in advance** and at least 2 days prior to the shipping of any semen (cheques to be cleared prior to shipping of semen, direct deposit preferred method of payment).

The Collection fee must be paid in advance and at least 2 days prior to the shipping of any semen (one Collection fee applies per stallion visit to Chalani's veterinary clinic for collection, rather than a collection fee per mare).

These fees must be paid to Chalani before semen is shipped to the mare owner or their nominated veterinary clinic.

All fees incurred by the mare owner are the responsibility of the mare owner alone.

### 3. **Approval of mares:** Preference will be given to registered Australian Stock Horse mares, or mares of proven performance and/or temperament. If a mare is considered to be an unlikely breeder another approved mare may be substituted.

If in the opinion of Chalani a mare is of doubtful temperament or breeding type, Chalani may decline to accept the mare for breeding to the stallion.

Photos and / or video may be required by Chalani prior to the mare being approved for breeding.

The mare shall be in a healthy and sound breeding condition, free from infections, contagious and or transmissible diseases.

4. **Mare identity:** The Mare Owner must submit identity details of the mare, including any and all markings, branding, microchip number if applicable, a copy of pedigree papers and photographs to Chalani. *Please ensure your own insemination veterinarian has a copy of these details as they may be required to sign service certificates.*
5. **Shipping semen:** Cost of container hire and freight is payable by the mare owner. We take no responsibility for the shipment once it leaves our collection point. Check your insurance situation with the freight company. Semen will be shipped after Christmas and before September *only in unusual circumstances.*
6. **Insemination:** To ensure first rate results, the mare owner must source and nominate an experienced AI reproductive centre that specializes in handling chilled semen with confirmed results, to carry out the insemination procedure. Should the insemination procedure be carried out by an un-nominated, unauthorized and or inexperienced AI veterinary centre, this contract will be null and void with no loss or responsibility falling on Chalani. If the mare is unable to settle in foal after three shipments of semen, an alternative mare (upon approval by Chalani) may be substituted as a replacement, with collection fees applicable. Attendance of the mare for live service at Chalani instead of AI will be considered on a case by case basis.
7. **Pregnancy Testing:** The mare is to be scanned by 21 days after insemination. If confirmed in foal, she must then be re-scanned at 45 days before a service certificate will be provided.
8. **Embryo Transfer:** If the nominated mare is to be used for embryo transfer the mare owner must clearly declare this, as an addendum in this contract. The mare owner is to supply registration papers and/or identity details of the recipient mare to Chalani. A veterinary certificate must be provided to Chalani specifying the details and dates of the embryo transfer into the recipient mare.
9. **Return Rights:** No responsibility or cost, whole or in part, for whatever reason will fall upon Chalani for loss of foal (in utero or thereafter).

Chalani will accept the mare for free return service no later than during the consecutive season, only upon payment of the booking fee and collection fees.

Should the mare slip or fail to produce a live foal, Chalani must be notified within 48 hours. A veterinary certificate confirming the mare is not in foal, or no live foal has been produced, may be requested. Chilled semen collection and shipping charges apply for re-breeding.

If a mare is neglected or undergoes any veterinary interference which terminates the pregnancy (twinning excepted), or the mare is not re-booked to Chalani by the following breeding season, this contract becomes null and void.

If the stallion dies, frozen or chilled semen is not available, the stallion is sold, or no substitute stallion is standing at stud at Chalani, this contract becomes null and void. *No refunds will be given.* Re-breeding in the same stud season does not require additional booking fees to be paid.

Service fees may not be on-sold or given to a 3<sup>rd</sup> party.

10. **Sale of in-foal mare:** If at the time of the sale the mare is no longer pregnant, or in good health, this contract becomes null and void. A veterinary certificate of pregnancy at the time of sale is recommended. Return breeding rights will be afforded to the new owner under the conditions of this contract.

11. **Liability:** Whilst every care will be taken, Chalani shall not be liable for any accident or injury occasioned to the mare or her foal at foot when undergoing any insemination or breeding procedure, nor will the mare owner be held responsible for any accident or injury occasioned to the stallion during semen collection. Insurance of mares is recommended.

12. **Service Certificate:** All progeny of studbook ASH Stallions may apply to be registered with the Australian Stock Horse Society upon payment of ASH membership fee, registration fee, and presentation of the official Stallion Service Certificate. All requirements set down by the Australian Stock Horse Society need to be met in order to apply for registration and are available from the ASHS website or head office.

**An ASH service certificate will be supplied following 45 day positive pregnancy test of the mare.**

Progeny of Dilutes Australia (DA) registered stallions, are eligible to apply for Dilutes Australia foal recording.
